## REFUND POLICY

### RECREATIONAL REFUNDS

#### OUTDOOR SEASON

Before April 1 <sup>st</sup>	A full refund will be issued less \$25 administration fee.
Between April 1 <sup>st</sup> and the second game of the season	A full refund will be issued less a \$100 administration fee.
After the second game of the season	No refunds will be issued unless it is due to a medical reason.

#### FALL SEASON

Before October 15 <sup>th</sup>	A full refund will be issued less \$25 administration fee.
Between October 15 <sup>th</sup> and the second game of the season	A full refund will be issued less a \$100 administration fee.
After the second game of the season	No refunds will be issued unless it is due to a medical reason.

#### WINTER SEASON

Before December 15 <sup>th</sup>	A full refund will be issued less \$25 administration fee.
Between December 15 <sup>th</sup> and the second game of the season	A full refund will be issued less a \$100 administration fee.
After the second game of the season	No refunds will be issued unless it is due to a medical reason.

## REFUND POLICY

- If a player needs to withdraw due to medical reasons, a medical document will be required with the refund request form.
- Players will receive a partial (pro-rated) refund for any medical issues that occur prior to 50% completion of the season.
- Medical forms must be sent to the Club within 2 weeks of sustaining the injury or the refund request will be rejected.
- NO refunds will be issued after 50% completion of the season.
- If a uniform was received, the full uniform kit (shorts/socks/jerseys) must be returned (washed) for a refund to be issued.
- There will be no refunds if a parent or player disagrees with the coach, team, or tier placement the player is assigned to.
- There will be no refunds if a player or parent is suspended or expelled from Brams United under the Club's Discipline Policy or Code of Conduct Policy or that of one of our governing bodies.

## REP PROGRAM REFUNDS

Club's First Installment	NON-REFUNDABLE
Any Tournament Fees	NON-REFUNDABLE

- All Refunds are subject to a \$125 Administration fee.
- There will be NO REFUNDS after January 31.
- There will be no refunds if a parent or player disagree with the coach, team or tier placement the player is assigned to.
- There will be no refunds if a player or parent is suspended or expelled from Brams United under the Club's Discipline Policy or Code of Conduct Policy or that of one of our governing bodies.

## CAMPS, SUPPLEMENTAL PROGRAMS, SPECIAL EVENTS

- All refunds are subject to a \$25 Administration fee.
- Refund requests will only be accepted 10 days prior to the first day of the program. NO REFUNDS will be issued after.
- Special events and tickets are NON-REFUNDABLE.
